- c. If no feedback is provided continuously on three occasions desired by the institution.
- d. If no response is coming for seeking any suggestion in spite of repeated request.
- e. If alumni works against the interest of Shri Shakti Degree College and or Alumni Association.
- f. Any other act of indiscipline causing damage to the quality improvements in teacher's education.

PROCEDURE FOR EXPULSION

- 1- Any alumni may be expelled under the signature of General Secretary after offering reasonable opportunity for natural justice.
- 2- Appeal :- any member has got right to make an appeal to the President of Alumni who may revoke or uphold the expulsion order, subject to the consent of committee of all office bearers. However this also has to be got approved in the General Body meeting of association.
